Dear Shareholder.	

We are pleased to inform you that the Board of Directors of your Company on **May 05**, **2025** have declared 4<sup>th</sup> Interim Dividend of Rs. 19/- per share for the Financial Year 2024-25. The Record Date for the purpose of determining the entitlement of the shareholders for the Interim Dividend has been fixed as **May 12**, **2025**.

In accordance with the provisions of the Income Tax Act, 1961 (the "Act") as amended by the Finance Act, 2020, dividend declared and paid by a company shall be taxable in the hands of the shareholders and the Company is required to deduct tax at source (TDS) from dividend paid to the shareholders at the applicable rates as per the provisions of the Act. We shall therefore be required to deduct tax at source (TDS) at the time of making the payment of the said Dividend. The withholding tax rate would vary depending on the residential status, category of the shareholder and the documents submitted by them and accepted by the Company.

This communication summarizes the applicable TDS provisions, as per the Act, for resident and non-resident shareholders, specific categories together with documentation requirements from them to enable us to comply with the TDS related statutory obligations. The applicable rates and documentation requirements from the shareholders are tabulated below:

#### Shareholders having multiple accounts under different status / category:

Shareholders holding shares under multiple accounts under different status / category and single PAN, may note that, higher of the tax as applicable to the status in which shares are held under a PAN will be considered on their entire holding in different accounts.

\*\* The Company is not obligated to apply the beneficial Tax Treaty rates at the time of tax deduction/withholding on dividend amounts. Application of beneficial Tax Treaty Rate shall depend upon the completeness of the documents submitted by the Non-Resident shareholder and review to the satisfaction of the Company.

The aforesaid documents, as applicable, are required to be sent to Company at email Id. <a href="mailto:lnvestors@coforge.com">lnvestors@coforge.com</a> or, the Registrar and Transfer Agent ('RTA') at <a href="mailto:rta@alankit.com">rta@alankit.com</a> on or before <a href="mailto:May 17">May 17</a>, 2025 to enable the Company to determine the appropriate TDS rates. No communication on the tax determination/deduction received post <a href="mailto:May 17">May 17</a>, 2025, shall be considered for payment of the Interim Dividend. It is advisable to submit the documents at the earliest to enable the Company to collate the documents to determine the appropriate TDS rates.

If the dividend income is taxable in the hands of any person other than the recipient of the dividend, then the requisite details by way of a declaration in **Annexure 6** should be communicated to the Company/RTA by **May 17, 2025**.

In case tax on dividend is deducted at a higher rate in the absence of receipt of the aforementioned details / documents, you would still have the option of claiming refund of the excess tax paid at the time of filing your income tax return. No claim shall lie against the Company for such taxes deducted.

If the PAN is not as per the database of the Income-tax Portal, it would be considered an invalid PAN and higher TDS, as per law, may be done.

In the event of a mismatch in the category of shareholder as per the register of members and as per fourth letter of PAN, the Company would consider fourth letter of PAN for applying the surcharge rate.

We also request you to submit / update your bank account details with your Depository Participant, in case you are holding shares in the electronic form. In case your shareholding is in the physical form, you are required to submit KYC forms duly filled up and documents duly signed by the all the shareholders, along with a cancelled Cheque leaf name preprinted and a copy of your PAN card, duly self-attested, Nomination details, contact details email Id and Mobile number. This will facilitate receipt of dividend directly into your bank account and intimation thru email. In case the cancelled Cheque leaf does not bear your name pre-printed, please attach a copy of the bank pass-book statement, duly self-attested. We request you to submit KYC forms and documents in physical forms to RTA Agent Alankit Assignments Limited, Alankit House 4E/2 Jhandewalan Extension New Delhi - 110055, INDIA and email to <a href="mailto:rta@alankit.com">rta@alankit.com</a> with a copy to the Company at <a href="mailto:investors@coforge.com">investors@coforge.com</a>.

## **Important Communication for Members regarding KYC updation:**

For members who hold shares in physical form, the Securities and Exchange Board of India ("SEBI"), vide its Master Circular SEBI/HO/MIRSD/POD-1/P/CIR/2023/70 dated 17<sup>th</sup> May 2023, as amended from time to time, has mandated furnishing of PAN linked with Aadhaar, KYC details (i.e., postal address with PIN code, e-mail address, mobile number, bank account details, etc.) and nomination by holders of securities.

In terms of SEBI Master Circular dated 7th May 2024 read with SEBI Circular dated 10th June 2024, members holding shares in physical form who have not updated their KYC Details shall not be eligible to lodge grievance or avail any service request from the Registrar & Share Transfer Agent ("RTA") only after updating their KYC Details.

Further, with effect from 1st April 2024, any payment of dividend shall only be made in electronic mode to such members. If KYC is not updated by physical shareholders, dividend payment would be in abeyance.

We urge you to complete your KYC Details to get dividend and communication to avoid any inconvenience in the future.

For members who hold shares in demat form, they should keep their bank details, e-mail address, postal address, contact number and nomination details updated in their demat account(s) maintained with Depository Participant(s) for electronic mode of payment of dividend.

Further, SEBI has mandated that securities of listed companies can be transferred only in demat form. To avail various benefits of dematerialization, members are advised to dematerialize shares held by them in physical form, for ease in portfolio management and dividend pay-out.

Members may refer to SEBI Master Circular, relevant Investor Service Request Forms, KYC forms and contact details for sending requisite forms/ documents at RTA/or Company website.

We shall arrange to email a soft copy of TDS certificate to you at your registered email ID in due course, post payment of the dividend and completion of statutory formalities. In addition, to verify the tax deduction, the shareholders can also check their Form 26AS/ Annual Information Statement (AIS) from their e-filing account at Online 26AS e-filing Website (incometaxindia.gov.in)
